



## **Construction Dumpster Rental Agreement**

**4-Yard:** \$103.00 each time emptied + \$7.00 per day rent (5'Wx7'Lx4'D) **\$130.00 Deposit**

**6-Yard:** \$138.00 each time emptied + \$7.00 per day rent (5'Wx10'Lx4'D) **\$130.00 Deposit**

**10-Yard, 20-Yard, & 30-Yard Roll-off Containers:**

\$130.00 each time emptied + \$7.00 per day rent + \$59.00 per ton **\$130.00 Deposit**

**MINIMUM ONE PULL REQUIRED PER MONTH**

**Dry Run Fee (dumpster inaccessible): \$45.00**

**Fee to relocate/move a dumpster without empty: \$65.00**

**Transportation fee: \$150.00 + current landfill rates (tonnage minimum \$225)**

**TERMS AND CONDITIONS**

- 1) Customers are prohibited from moving dumpsters with heavy equipment and will be held liable for damage to dumpsters. Please call office to have dumpster moved.
- 2) Dumpsters must not be overfilled. Waste protruding above the top will prevent emptying.
- 3) **LARGE PIECES OF CONCRETE ARE NOT ACCEPTABLE.** Loads rejected by the Transfer Station will be direct hauled to the landfill at an additional cost of \$150 plus tonnage.
- 4) **Customer assumes responsibility for any damage to yard, concrete or other property due to delivering or removing the dumpster.**
- 5) Payment is due, in full, on invoices within 15 days. If your account becomes more than 60 days past due, we reserve the right to send your account to collections.

**NOT ACCEPTABLE in 4-yard and 6-yard dumpsters:**

- Tires & major appliances (washer, dryer, stove, refrigerator, water heater, dehumidifier, etc.)
- Yard waste (limbs, grass clippings, leaves, etc.)
- Heavy remodeling debris: sheet rock, ceramic tile, etc.
- Automotive (lead/acid) batteries
- Long pieces of pipe, angle iron or tubing (pieces 3 feet or less are acceptable)
- Heavy pieces of metal (I-beams, structural steel, automobile motors, car parts, etc.)
- Concrete, bricks, blocks, rocks, etc.
- Absolutely **NO** chemicals, paint or stains, hazardous or special/regulated wastes, oil, or any other liquids

**NOT ACCEPTABLE in 10, 20 or 30-yard dumpsters:**

- Tires & major appliances (washer, dryer, stove, refrigerator, water heater, dehumidifier, etc.)
- Yard waste (limbs, grass clippings, leaves, etc.)
- Automotive (lead/acid) batteries
- Absolutely **NO** chemicals, paint or stains, hazardous or special/regulated wastes, oil, or any other liquids
- **If used for concrete, rock, dirt, etc. a 20-yard is the MAXIMUM size allowed. \*See above: Terms and Conditions, #3.**
